NOTICE FOR 1st MOP-UP ROUND OF COUNSELLING FOR FILLING VACANT SEATS OF BAMS/BHMS UNDER STATE/ALL INDIA QUOTA IN GOVERNMENT/ PRIVATE AYURVEDIC/ HOMEOPATHY COLLEGES FOR THE ACADEMIC SESSION-2019-20

Pursuant to the directions received from the Government of H.P. 1st Mop-up Round of Counselling for filling up BAMS/BHMS vacant seats under State/All India Quota in the Rajiv Gandhi Govt. Post-graduate Ayurvedic College, Paprola and the private Ayurvedic/Homeopathy Colleges situated in the State of Himachal Pradesh shall be conducted **on 06.09.2019 at 11.30 AM in the H.P. University Auditorium, Summer Hill, Shimla-5**. All interested wait listed candidates who attended the 2nd round of counselling held on 20.08.2019 and including those admitted/allotted candidates of private Ayurvedic/Homeopathy colleges who are eligible for up-gradation/shifting in order of merit under State Quota seats in the Rajiv Gandhi Govt. Post-graduate Ayurvedic College, Paprola and from All India Quota to State quota in the private Ayurvedic/Homeopathy colleges, may report for counselling for admission to BAMS/BHMS course on the above mentioned date, time & venue.

The list of such candidates to be called for the aforesaid counselling shall be uploaded on the University website www.hpuniv.ac.in, www.admissions.hpuniv.ac.in on **04.09.2019** **alongwith tentative vacancy position**. Therefore, the candidates are advised to make themselves present in the counselling. In case of unavoidable reasons, the candidate can depute his/her authorised representative with a letter of authority to attend the aforesaid counselling, failing which his/her claim for admission shall be forfeited. Candidates those not admitted in any of the college must bring with them all original certificates on the day of counselling.

Besides this, the candidates who are interested for seeking admission to BAMS/BHMS courses only against vacant seats under State/All India Quota in the private Ayurvedic/Homeopathy Colleges pursuant to the directions received from the Government of H.P. the afresh applications are hereby invited from the eligible and qualified candidates of NEET-UG-2019 for filling up vacant seats under State/All India Quota in the private Ayurvedic/Homeopathy Colleges only on the prescribed Application Form (**as uploaded on the University websites**) on or before 04.09.2019 upto 5 PM by sending the copy of application form and the Result Card of NEET-UG-2019 by e.mail arentrancetests919@gmail.com to the University. However, the copy of the original application form alongwith requisite certificates/documents and Bank Draft of application fee of Rs.2000/-for General & others categories and Rs.1000/- for SC/ST categories shall be submitted personally at the time of counselling **on the day of counselling i.e. 06.09.2019**.The candidates who are already exists in the waiting list on the basis of 2nd round of counselling are no need to apply afresh. The candidates are also required to bring with them cash Rs. 20,000/- (Twenty thousand only) as per provision 11(Note) at page no.23 of the prospectus. The candidates those applied afresh, their merit list shall be prepared separately and the same shall be operated after exhausting the main waiting list of the 2nd round of counselling strictly as per provisions of the prospectus. The candidates who had not attended 1st, 2nd round of counselling may also apply on the prescribed application form as mentioned above.

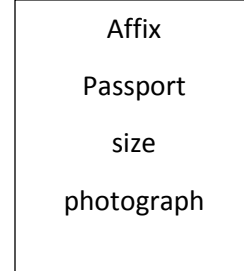
